AGULHAS PLAIN BIRDING PROJECT YEARLY REPORT 2016

INTRODUCTION

In the 2015 "yearly report" a 5-year strategy was announced for the Agulhas Plain Birding Project. This meant that the Project would end with the final report in 2020. To make the interim yearly reports more user friendly, it will be shortened substantially and written in a more cryptic form. The final report in 2020 will then be written in thesis format.

So, did we achieve the goals set in the previous report? Here is a short summary:

- 1. After the addition of 4 new pentads there now are 27 pentads to be surveyed for the project. This was achieved early in December. 32 Checklists were submitted this year which brings the total for the project to 183.
- 2. Birdlasser was employed for all checklist submission to SABAP2. Although there were some niggles here and there it made a massive difference to productivity and accuracy. Thanks, Birdlasser team!
- 3. Bird hide development is at a stalemate. Work overload being the main obstacle, but 2017 hopefully will be a year of action!
- 4. The Agulhas Plain Birding Project website should be launched before the end of March! This will be a work in progress. Thanks to Sam Beeslaar who has spent endless hours designing the website!
- 5. The Buttonquail Bash for 2016 was cancelled as it was planned on Big Birding Day which proved to be a judgement error. Role players agree that we should find another more suitable date.
- 6. Bird guide training was last done November 2015. The Park received 3 pairs of second-hand binoculars during the year to be used by rangers. The Birds of the Agulhas Plain PowerPoint training module was updated and improved this year. Further training should be initiated by management.
- 7. A further 20 new species were added to the Agulhas Plain Birding List. The list now stands at 255! Ten of these were historical from reliable data received (including photograph). The list excludes new species reported (often by very experienced birders) but not confirmed by photograph or call recording. The new species recorded in 2016 and fulfilled protocol requirements, were:
 - a. Black Cuckoo
 - b. African Goshawk
 - c. Verreaux's Eagle
 - d. Buff-spotted Flufftail
 - e. Lesser Striped Swallow
 - f. African Grass-Owl

- g. Western Osprey
- h. Black Cuckooshrike
- i. Baillon's Crake
- j. Knysna Woodpecker

Habitat: Only half of this pentad falls within the Agulhas plain. It is drained by the Koue and Bloed rivers. The South-Western corner has some smallholdings and the Tierkloof Conservancy near Baardskeerdersbos with small dams. The South-Eastern pentad includes the very interesting De Kouderivier farm. The rest of the pentad is cultivated land and alien forest with a track that covers mountain fynbos.

Habitat: Includes large tracts of cultivated land on De Koude river farm, the Koue river with large sedge marshes which runs into the Janswartskraal river, large alien forests and a gravel road that runs past farm yards with small dams, just below the Soetmuis mountain.

Habitat: Nuwejaars river and marshes, Langpan, Rondepan and Northern third of Voelvlei. Cultivated land, natural fynbos and alien forest.

Habitat: Largely cultivated land with the natural fynbos Heuningrug taking up most of the habitat. Small farm dams and 2/3's of Rondepan.

Habitat: Cultivated land, large wetland area due to Kars river ending in flat plain, Varkvlei, Manmade canals made to drain the area towards Heuningnes river. Small patches fynbos and alien forest.

Habitat: The Kars river ends in a delta in this pentad which forms a wetland before it forms again into the Kars river in the Grooteiland pentad. Largely cultivated land with patches of gumtree forests. Water canals deviated from the Kars river runs to Vogelgezang and feeds into this wetland.

Habitat: The Ratel river marsh lands, Soetwaterfontein, cultivated land, Uintjiekuil pan, Uintjiekuil dam, Alien forest patches, rehabilitated fynbos/marshes Ratel river plain. Wolvengat semi-urban area.

Habitat: Cultivated land, alien tree patches, Uintjieskuil and river, small patches natural fynbos, Melkbospan and vlei and Vispan (salt pan).

Habitat: Natural fynbos Soetanysberg, Voelvlei, some seasonal pans, cultivated land, 4 dams West of Springfield Saltpan and Western edge of the Saltpan. Small portion of the Nuwejaars river wetland.

Comments: This pentad has varying habitats and is probably one of the most exciting in the Agulhas Plain. This is the only pentad that has produced Sentinel Rock Thrush(Soetanysberg). The Voelvlei can produce almost any water bird depending on the level of the vlei.

Habitat: Zoetendals vlei, Nuwejaars river wetland, Springfield Saltpan, Cultivated land and renosterveld.

Habitat: Most of the Heuningnes river, cultivated land, various small pans and natural fynbos. Southern part of the De Mond Nature Reserve. Andrews Field Nature reserve fynbos with coastal dunes.

A further highlight was early in December when approx. 30 000 terns and 7 000 Cormorants were counted (with the use of panoramic pictures) on that day.

There seems to be a breeding pair of Black Harrier in the area, but the area will always be visited for a guaranteed view of Bank Cormorant and perhaps Crowned Cormorant.

Highlights for the pentad was African Harrier-Hawk, Baillon's Crake, Forrest Buzzard and Wattled Starling.

Habitat: Urban area surrounded by natural fynbos, coastal dune veld and Langerzandt Wetland.

Comments: This pentad had some great surprises. African Rail, Cardinal and Knysna Woodpecker, Peregrine Falcon, Secretary Bird and Water Thicknee were new species for the pentad.

CHALLENGES for 2017

It has become a challenge to cover all 27 pentads in one year as I am on average only once a month in Struisbaai. For this reason, the appointment of Erica Brink as conservation officer will be a great asset as she could be utilized in recording the more Western Pentads of the Nuwejaars river SMA. In the same vein, Lindsay Lewis, Western Section ranger AGNP could be approached to increase the data for the Western Agulhas Plain.

It seems that the legally acceptable way to collect funds for bird hide development will require that the Agulhas Birding Project register as NGO, which means it must be audited. This will also make it easier for corporates to sponsor the project.

The Langerzandt Wetland is currently under pressure due to further development of Langerzandt. Contact has been established with the developer who has responded positively and would like our input with regard the wetland.

The Agulhas National Park and Nuwejaars river SMA, are more interested in Mybirdpatch records as this is more relevant to them for marketing. What they need to know is e.g.: what species occur at Voelvlei or Zoetendalsvlei or Renosterpan or at Ryspunt Peninsula or on a specific farm such as Visserdrift. Most of these attractions though are covered by

more than one pentad. So, for 2017, the strategy will be to record using MYBIRDPATCH primarily.

CONCLUSION

It is difficult to believe that after 7 years we are still identifying new species in the Agulhas Plain in such large numbers. This surely cannot go on forever. It is however realistic to target 5 new species for 2017. Target species for 2017 will be:

Rufous-cheeked Nightjar (please call me if you hear them calling)

African Quail finch

Swee Waxbill(one record so far)

Baillon's Crake(one record heard only)

Spotted Crake

Cape Penduline-Tit

Cape Rock-Thrush

Cape Siskin

European Bee-eater

European Honey-Buzzard(One record)

Great Egret

Ground Woodpecker

Jacobin Cuckoo

Karoo Korhaan

Lemon Dove

Little Sparrow-hawk

Marsh Owl(Waschkraalvlei)

Sand Martin and

Willow Warbler.
